3. Notwithstanding anything to the contrary contained hereinabove, the maximum liability
under this guarantee is restricted to **USD 400/-**.

4. Notwithstanding anything to the contrary contained hereinabove, this guarantee is valid from
(***date of issue***) up to the (***date after 180 days from date of issue***) and claims under this guarantee
should be submitted not later than (***date after 180 Days from date of issue***).

5. This guarantee may not, without our prior written consent, be transferred or assigned and this
guarantee is limited to the payment of a sum of money.

6. This guarantee shall be governed and construed in accordance with the laws of the ***Sudan***
and is governed by the United Rule for Demand Guarantee (URDG) (ICC Publication No.758) and
shall be subject to exclusive Jurisdiction of the ***Sudanese courts***.
